

## Purpose

This course is designed to provide rehabilitation healthcare professionals (RN's, LPN's, Case Managers), the knowledge needed to care for patients in rehabilitation settings across the continuum of care. This course is also intended to be a comprehensive review for the CRRN examination.

## Description

The course involves three full day sessions using lecture, discussion and demonstration to cover the important aspects of care in rehabilitation. The content will cover anatomy and physiology, specific disease processes and the rehabilitation treatment plans required to successfully care for these patients. This course is grounded in the interdisciplinary perspective even though there is a strong nursing focus.

Assist in preparation for the CRRN examination

Provide recertification hours to renew for CRRN

Self care & ADLs; SCI; burn rehabilitation; diversional activity; pain management; amputees; sexuality & sexual function; case management; team & communication; performance improvement & program evaluation; test taking strategies
